Renovation Phase 1 complete, Phase 2 begins

Phase 1 of renovation to The Medical Center's first floor main corridor is complete. Employees can now see the cosmetic updates that are being made, including new flooring, rails and paint.

With completion of Phase 1, the Outpatient entrance and lobby have reopened, and patient registration has returned to its normal process.

Phase 2 has begun and will last until approximately February 20. This phase will not have the impact on patients as Phase 1 did with the temporary relocation of Outpatient registration to Diagnostic Imaging. This phase will primarily impact wayfinding through the hospital. Alternate routes using back hallways will continue to be utilized during this time to bypass renovation areas.

During Phase 2, the following areas will be closed:

- Section between Outpatient and the Diagnostic Imaging hallway.
 - The revolving door access to the main hallway in this section will be closed.
- Small section of secondary hallway leading from main hallway to Pathology and High Street exit.
 - Patients and visitors looking for the Emergency Department should be directed to use the Café/Engineering hallway to exit the main hospital and cross High Street.
 - Staff can access Pathology by using the back hallway of Diagnostic Imaging.

- Small section of secondary hallway by Lab leading to Café/Engineering hallway.
 - The Critical Care Waiting Room will continue to be used as a pass-through to the Café/Engineering hallway.
- Section between Subway and Nursing Administration hallway.
 - Elevators 1 & 2 and 4 & 5 will be operational; however, elevators 4 & 5 cannot be accessed from the front. Both sets of elevators can be used for all patient floors. In addition to normal access via Elevators 4 & 5, Commonwealth Regional Specialty Hospital will be open through 6B, using the front side of Elevators 1 & 2.
 - One entrance to Subway will remain open.

What you can do

Please continue to assist patients and visitors in finding their way as you encounter them in our hallways. A renovation of this magnitude and scope affects the patient and visitor experience in our hospital. We want to minimize any inconvenience and confusion for them.

Vascular Screening

January 20

The Medical Center Health & Wellness Center located at 1857 Tucker Way off Cave Mill Road in Chandler Park. Appointments are required by calling 745-0942.

Assess your vascular health with three painless, noninvasive tests: carotid ultrasound, abdominal aortic ultrasound, and ankle/brachial index. These tests screen for disorders such as stroke, aortic aneurysm, and lower extremity vascular disease. A vascular technologist performs the screenings, results are sent to a board certified vascular surgeon at The Heart Institute, and a report is sent to you and your physician. The cost is \$35 per screening or \$90 for all three. Members of Senior Health Network, Men's Health Alliance and The Women's Center can get all three for \$80.
