## Scottsville Celebrates New Expansion

The Medical Center at Scottsville unveiled its 5,700 square foot expansion project estimated at nearly \$2.3 million during a Scottsville-Allen County Chamber of Commerce ribbon cutting on September 21.

A significant portion of the expansion is dedicated to the addition of a permanent MRI (magnetic resonance imaging) system. Prior to the expansion, the hospital offered mobile MRI services once a week. The EXCELART Vantage MRI system from Toshiba America Medical Systems enhances the hospital's diagnostic imaging services that recently upgraded to 4D ultrasound and digital mammography.

The expansion also includes new space for the hospital's Physician Specialty Clinics which previously shared space in the Scottsville Medical Plaza. The clinics continue to expand with the most recent addition of nephrology that includes Frank Boeteng, M.D., Julie Issac, M.D., Carlos Rotellar, M.D., and Scott Sims, M.D. Mohammed Kazimuddin, M.D. has also started seeing patients as part of the hospital's cardiology clinic. Other specialty clinics

include general surgery, neurology, obstetrics and gynecology, orthopaedics, psychiatry, and pulmonology.

"The relocation of the Physician Specialty Clinics provides the Rural Health Clinic with much needed space that has the potential to improve patient flow and wait times," said Eric Hagan, Vice President of The Medical Center. The Rural Health Clinic which is staffed by three physicians and two nurse practitioners see an average of 120 patients a day.

Another benefit of the building expansion is the connection of the Scottsville Medical Plaza to the hospital. Rural Health Clinic patients who have diagnostic imaging exams ordered will no longer have to walk between buildings for services but will have convenient, interior access to other hospital departments.

The American Heart Association's signature fundraising event, the Heart Walk, was kicked off on The Medical Center's front lawn at 9 a.m. on Saturday, September 10. The Warren County Heart Walk is sponsored each year by The Medical Center. ## CHC Receives Pioneer Award

On September 7, Commonwealth Health Corporation was presented a Pioneer Award by The Governor's Office of Electronic Health Information for contributions in advancing the Kentucky Health Information Exchange (KHIE). CHC was the first hospital group to have live access to the Exchange and the first two critical access hospitals to be live in the state.

KHIE is a system that allows healthcare providers to access a patient's health information — with the patient's consent — directly from electronic records of other hospitals, laboratories, physicians and diagnostic imaging centers. "I was particularly proud of this accomplishment," said Jean Cherry, Executive Vice President, "since, with the exception of Pikeville, we were live prior to the hospitals selected to participate in the pilot. Martin Reiter and our IT team did a great job bringing this project to a quick close."

One of the most important things the Exchange will do is provide caregivers access to a summary of patients' treatments at other facilities. "The more providers who participate," Jean said, "the more valuable it will be as a tool to facilitate the treatment of our patients."

For example, if a resident of Louisville visiting Bowling Green had a car accident or heart attack and was brought to The Medical Center's Emergency Department, our clinical staff would be able to access a medical history and summary of treatment the patient received from other providers in the state. This not only provides critical information when it is needed most, but also helps to reduce duplicate tests and treatments, keeping healthcare costs down.

The exchange of health information, such as through KHIE, is one of the requirements of Stage I Meaningful Use. Meeting those requirements gives hospitals and clinicians access to stimulus money contained in the American Recovery and Reinvestment Act of 2009. But the focus for CHC is always on patient care — and the Exchange will help improve outcomes for patients, especially in emergency situations where time and efficiency can mean the difference between life and death.

Congratulations to the IT team—Garry Ragland, Jason McCoy, Mark Hanson, and Martin Reiter—for their hard work and dedication in helping CHC achieve this prestigious award.

## NICU: Inspiring hope. Celebrating success.

### *Inspiring Hope.*

Parents with children in The Medical Center's Neonatal Intensive Care Unit (NICU) experience a very stressful time in their lives. They are scared, worried and unsure of what the future will hold for their premature or critically ill newborn. They need the support of the NICU staff to answer their questions, reassure them and help them care for their newborn. They also need the support of other parents who have been through the same situation.

The NICU "wall of support" was installed in September on the second floor of the hospital across from the Nursery windows. It is designed to inspire hope for these parents by sharing success stories of past patients. Ten framed posters feature photos of children cared for in NICU, representing then and now. Each poster includes a small photo(s) that shows how very small and fragile the child was when in the NICU. A large photo shows the child as they are today and provides parents with a glimpse of what the future can hold. Each poster includes the parent's story about their experience. As parents spend time with their child in the NICU, they have a constant reminder that others have been



through the same situation and can find hope through their stories.

### *Celebrating Success*

On September 11, the fourth annual NICU Reunion was held in the Auditorium to reunite former NICU patients and their families with physicians, nurses and staff members who were closely involved with their child's hospital stay. The children enjoyed fun activities and delicious treats, while parents shared stories of their children's progress and development. NICU staff beamed with smiles from ear to ear as they once again held the children.
